

**RESOLUTION NO. 34-2026-07-02**

**RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX  
IN EXCESS OF THE TEN MILL LIMITATION.**

Rev. Code, Sec. 5705.19, .191, .25, .26

The Board of Township Trustees of Clinton Township of Fulton County, Ohio, met in REGULAR session on this 2nd day of July, 2026, with the following members present:

Kevin Demaline  
Rick Frey  
Ivan Hite

Mr. Rick Frey moved the adoption of the following resolution:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Clinton Township, Fulton County, Ohio; and

WHEREAS, said Clinton Township has received and reviewed the certification from the Fulton County Auditor as to the current taxable value of this subdivision and the dollar amount of revenue that would be generated by the specified number of mills;

WHEREAS, the Fulton County Auditor has certified that such Renewal Levy will generate \$ 71,967.00, based on the current taxable value of the subdivision of \$ 271,612,750.00, assuming that the taxable value of the subdivision remains the same throughout the life of the Renewal Levy; and

WHEREAS, the Fulton County Auditor has also certified to the Board that the amount of the Renewal Levy (based on the Renewal Levy's "estimated effective rate" as defined in Ohio Revised Code Section 5705.01(Q), as required by Ohio Revised Code Section 5705.03(B)(2)(c)(i)) expressed in dollars, rounded to the nearest dollar, for each \$100,000 of the "county auditor's appraised value" (as defined in Ohio Revised Code Section 5705.01(P)), is \$ 9 (the "Estimated Cost"); therefore be it

RESOLVED, by the Board of Township Trustees of the Township of Clinton Township, Fulton County, Ohio, at least two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of Clinton Township (including the city of Wauseon) for the purpose of current expenses purposes, that the county auditor estimates will collect \$ 71,967.00, at a rate not exceeding three tenths (.30) mill for each one dollar of valuation, which amounts to nine dollars (\$ 9) for each \$100,000 dollars of valuation for a period of 5 years, which levy is a RENEWAL tax of (..30) mill; and be it further

RESOLVED, that said Clinton Township proceed with the levy of said tax and that the question of levying the RENEWAL tax be submitted to the electors of said Clinton Township (including the City of Wauseon) at the GENERAL election to be held at the usual voting places within said Clinton Township (including the City of Wauseon) on the 3rd day of November, 2026; and be it

further

RESOLVED, that said levy be placed upon the tax list commencing Tax Year 2026, first due in calendar year 2027, if a MAJORITY of the electors voting thereon vote in favor thereof; and be it further

RESOLVED, the form of the ballot to be case at the election on the question of the RENEWAL Levy shall be substantially as follows:

**CLINTON TOWNSHIP**

**PROPOSED TAX LEVY**

**(A majority affirmative vote is necessary for passage.)**

"An renewal tax for the benefit of Clinton Township, Fulton County, Ohio (including the City of Wauseon) for the purpose of current expense purposes, that the County Auditor estimates will collect \$ 71,967.00, at a rate not exceeding three tenths (.30) mill for each \$1 of taxable value, which amounts to \$ 9 for each \$100,000 of the County Auditor's appraised value, for five years, commencing in 2026, first due in calendar year 2027."

AND BE IT RESOLVED, that the Fiscal Officer of the Board of Township Trustees be and is hereby directed to certify a copy of this Resolution to the Board of Elections, Fulton County, Ohio, no later than ninety (90) days prior to the election upon which it will be voted and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
