-The Archbold Fire Department is in the process of ordering F-500 foam. As of now, we are low and could use 15 or so 5-gallon buckets. The cost per 5-gallon bucket is roughly \$184.75. The fire departments prefer to order this product together so that we can split the shipping cost. Due to the nature of the chemical, it costs extra to ship and can be cost prohibitive to some, this way every department receives a portion of the cost savings.

This foam is utilized in 802 and 807, and is used as needed, it is not used on every fire.

The Trustees discussed it and told them to go ahead with it.
